

## **Notice of Amendment to Code of Business Conduct and Ethics**

On June 25, 2026, the Board of Directors (the “Board”) of Jade Biosciences, Inc. (the “Company”), acting upon the recommendation of the Board’s Audit Committee (the “Audit Committee”), approved and adopted a revised Code of Business Conduct and Ethics (as revised, the “Code”), which amended, restated, and replaced the Company’s prior Code of Business Conduct and Ethics (the “Prior Code”). The Code applies to all directors, officers and employees of the Company. The Board reviews the Code periodically and amends it as appropriate.

The Code was revised, in connection with the adoption of an Anti-Corruption Compliance Policy, to clarify and revise provisions relating to: (i) gifts, meals and entertainment; (ii) dealings with government officials and agencies; and (iii) anti-corruption compliance. The amendments also include other non-substantive revisions and administrative changes.

The Code does not materially change the responsibilities and obligations that previously applied to directors, officers and employees under the Prior Code. The adoption of the Code did not relate to, or result in, any waiver, explicit or implicit, of any provision of the Prior Code.
